Overview of Government Relations

- Support and sponsor legislation that advances the goals of the *Vision for Success*.
- Represent the Chancellor's Office in legislative and oversight hearings.
- Plan and coordinate advocacy days, legislative briefings, and other presentations.
- Provide technical assistance to legislative policy and fiscal committees and Department of Finance.
- Coordinate with our Washington DC based federal liaison on federal legislation and regulations.

Summary of 2022 Legislative Session

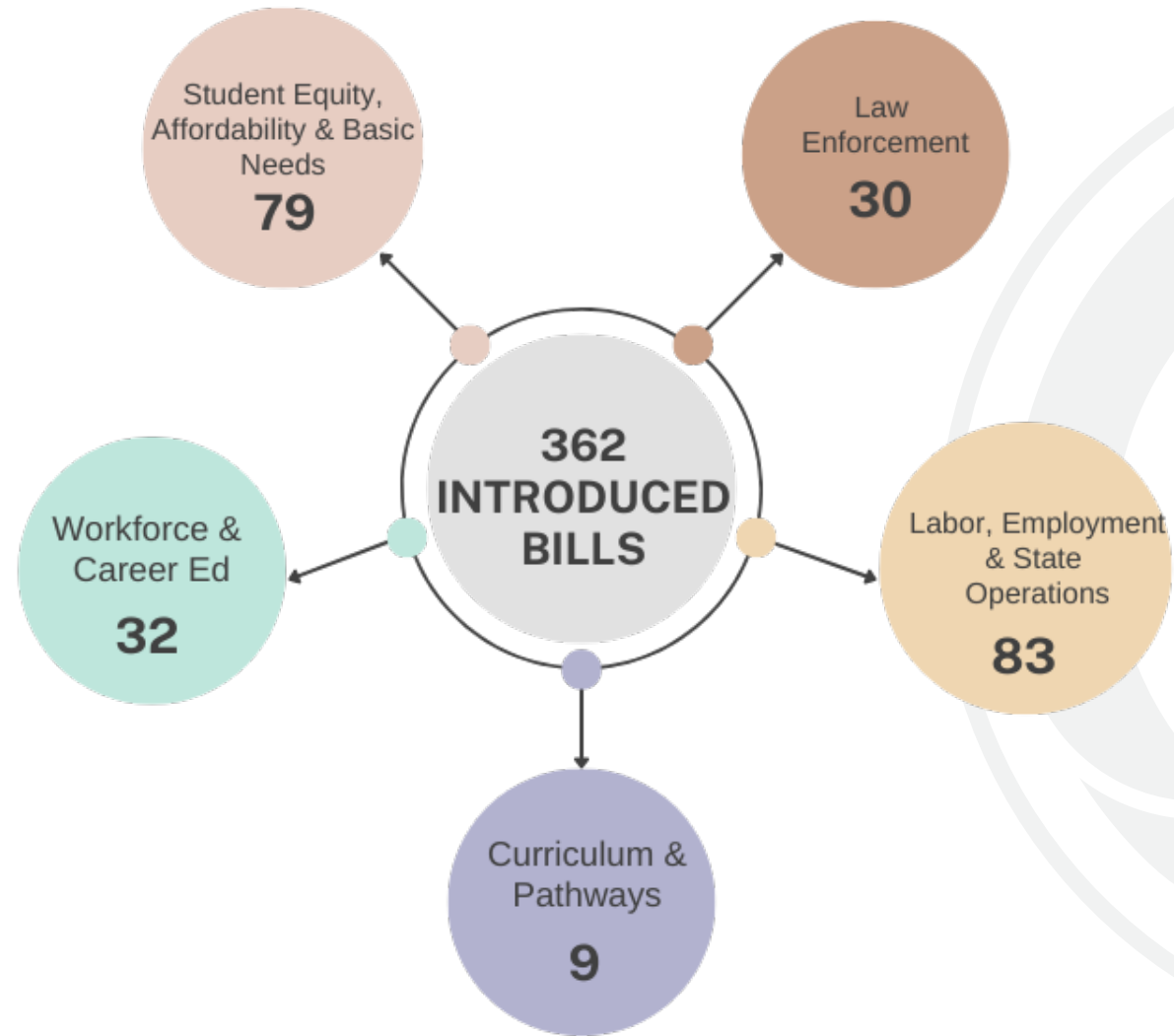
Thousands of **bills were introduced** and **1,166** made it to the **Governor's desk**

362 bills were identified as having an impact on higher education

Of those, more than 80 bills were classified as Tier 1 (likely having have a direct impact on the CCCs)

Many were vetoed, but 40 Tier 1 bills were signed into law

The clock starts again: the next legislative session begins on December 5th





High-Priority Chaptered Legislation

AB 1705 (Irwin)

Prohibits colleges from placing and enrolling students in pretransfer-level math or English coursework except under very limited circumstances.

- Issue guidance on the bill's requirements.
- Elevate best practices for ensuring students are informed and placed in the appropriate courses.
- Support colleges in continuous improvement through data collection and program evaluation.

AB 1187 (Irwin)

Provides that supervised tutoring for foundational skills and for degree-applicable and transfer-level courses is eligible for state apportionment.

- Update Board of Governors regulations.
- Update our fiscal reporting tools to allow colleges to report on supervised tutoring FTES.

AB 1491 (McCarty)

Requires the Chancellor's Office and CDE to provide technical assistance to adult education consortiums with excessive carryover.

- Support districts in reducing their year-to-year carryovers.
- Elevate the intent and goals of the Adult Education Block Grant Program.

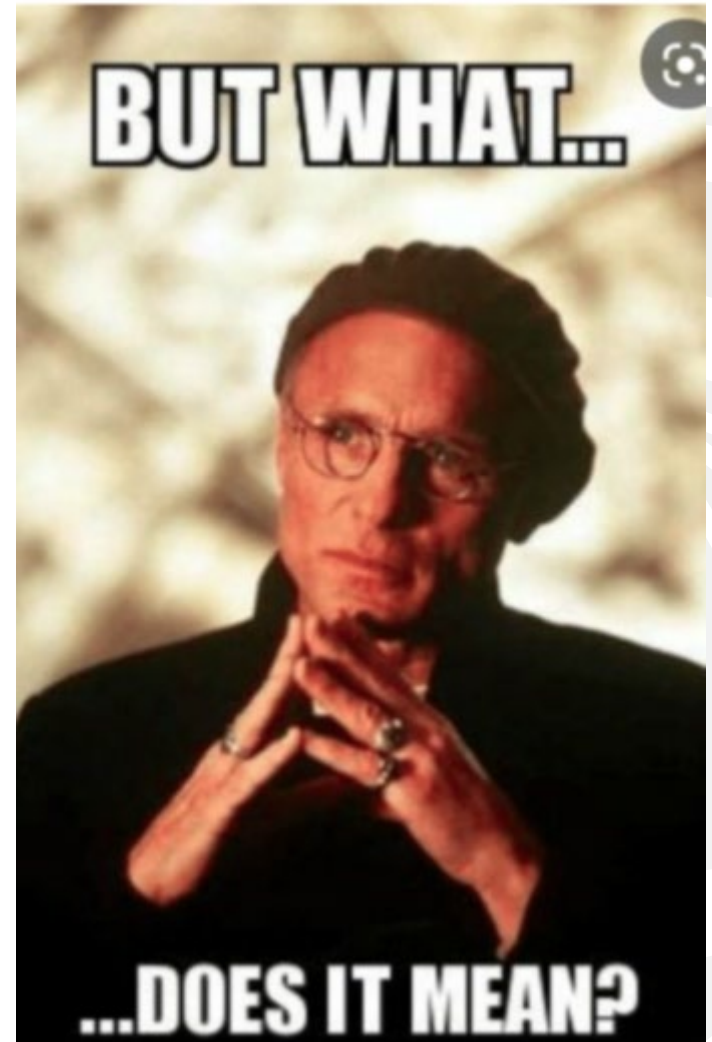

Staying Up to Date on Legislation

Tracked Legislation

The Legislature reconvened for the second year of the two-year legislative session on January 3, 2022. To date, we have identified **107 two-year and newly introduced bills** that have an impact on higher education or the Chancellor's Office. Of these, 48 are classified as Tier 1 and most likely to have a direct impact on the California Community Colleges, our faculty, and our students. The last day to introduce new legislation is February 18.

Tier 1: Bills that have a direct effect on the California Community Colleges, students, faculty, staff, and/or Chancellor's Office.

Tier 2: Bills that have an effect on state or local agency operations (Chancellor's Office generally does not take positions).

Tier 3: Bills that have an effect on educational partners, including the UC, CSU, CSAC, K-12, etc. (Chancellor's Office generally does not take positions).

Tier 4: Budget or budget trailer bills.

Tier 5: Chaptered legislation or resolutions.

Enacted Bills 2021

Chaptered Legislation Report

October 9th marked the end of the first year of the 2021-22 Legislative Session, with Governor Newsom taking final actions on bills approved by the Legislature in 2021. Of the 2,400 bills collectively introduced by the Assembly and Senate, we identified 203 bills relating to the California Community Colleges and/or the Chancellor's Office. Governor Newsom signed 91 bills relating to our system into law. The Governor approved the only bill sponsored by the Chancellor's Office and 10 of the 17 bills supported by our office. Of the four bills with an Oppose position, one bill died; one was made into a two-year bill; one was signed into law; and one received amendments that moved our office to a neutral position.

The Legislature will reconvene for the second year of the two-year legislative session on January 3, 2022. Approximately 106 bills related to higher education could be acted upon next year.

Issue

The Chancellor's Office Government Relations Division will provide Consultation Council with a State and Federal Update.

Background

California law (Ed Code § 70901(b)(4)) requires the Board of Governors (Board) to provide representation, advocacy and accountability for the system before state and national legislative and executive agencies. The Procedures and Standing Orders of the Board of Governors (Procedures and Standing Orders) provide guidance to the Chancellor in representing the California Community Colleges on matters pending before the California Legislature and Governor, Congress, and the President. The Procedures and Standing Orders also authorize the Chancellor to take positions on pending legislation on behalf of the Board, as specified (Procedures and Standing Orders § 317).

The Government Relations (GR) Division represents the Chancellor and the Board on state and federal policy and advocacy matters, and advocates for legislative and policy changes consistent with the Vision for Success, the 2023-24 System Budget Proposal, and 2022 Legislative Guiding Principles. The GR Division seeks feedback from the Consultation Council and the Board of Governors prior to taking positions on pending policy matters, including state and federal legislation.

Part-Time Faculty Health Insurance Program



FUNDING INCREASED

Definitions

An adjunct faculty is either:

1. Part-time faculty

Teaching assignment $\geq 40\%$ at one district of minimum full-time teaching assignment

or

2. Multidistrict part-time faculty

Teaching assignments at 2 or more districts $\geq 40\%$ of minimum full-time teaching assignment

DRAFT

Funding Allocation

1

In the initial allocation, districts receive up to 50% of the cost of the individual premiums paid.

2

Any remaining funds will be allocated to districts meeting the criteria, up to 100% of premiums paid.

3

Funds will be allocated proportionally based on each district's costs for those districts that submit a claim.

4

If funds remain after all apportionments, the remaining balance shall **revert** to the General Fund **annually**.

Eligibility Requirements for 100% Reimbursement

Offer health insurance to all part-time faculty

Offer part-time faculty the same health insurance benefits provided to full-time faculty at the district.

Limit individual premiums paid by part-time faculty to no more than the actual individual premiums paid by full-time faculty in that district.

Offer health insurance reimbursement to all multidistrict part-time faculty

DRAFT

Multidistrict Faculty Reimbursement Program

Districts shall reimburse a proportionate share of the total premium paid by the faculty member,

up to a proportionate share of the maximum of the full cost of the district's most commonly subscribed family coverage plan.



DRAFT

Documentation from Multidistrict Faculty

A district may require reasonable documentation from a multidistrict faculty:

- Verification that total cumulative teaching assignment $\geq 40\%$
- Verification of enrollment in a health insurance plan and the premium paid

DRAFT Multidistrict Faculty Reimbursement Calculation

A = total premium paid by the faculty

B = total number of districts in which the faculty works

C = % of health care cost paid by the district toward the total cost of the premium

District's proportionate share = $(A \div B) * C$

Multidistrict Reimbursement Example

A multidistrict part-time faculty works at 2 districts and pays a total premium of \$20,000 annually.

District 1 – multidistrict faculty teaches 35% of a full-time load at District 1;
district reimburses 50% of total premium cost.

District 2 – multidistrict faculty teaches 5% of a full-time load at District 2;
district reimburses 60% of total premium cost.

A = total annual premium paid by the faculty = \$20,000

B = total number of districts in which the faculty works = 2

C = % health care cost paid by district toward total cost of premium = 50% and 60%

District's proportionate share = $(A \div B) * C$

District 1 proportionate share = $(\$20,000 \div 2) * 50\% = \$5,000$

District 2 proportionate share = $(\$20,000 \div 2) * 60\% = \$6,000$

Further Considerations and Exploration

- Exploration of a statewide program or pool to leverage economies of scale
- Value of a standardized form and sample verification for multi-district part time faculty reimbursement
- Assignments can change even within sessions if courses are added or cancelled
- Eligibility Requirements from insurance providers
- Exploration of proportionate share calculation
