

## Guided Pathways Regional Coordinator Positions

*Guided Pathways* is an integration framework driving to optimize system and college cohesion in order to advance the *Vision for Success* and visibly transform the student experience. The Chancellor's Office will identify Regional Coordinators in two ways. It will either award grant funds to Chabot-Las Positas Community College District to enter consulting contracts for Regional Coordinators, or it will enter Interjurisdictional exchange agreements (IJEs) with an employing community college district for the services of a Regional Coordinator. These Regional Coordinators will assist colleges with the development of innovative strategies to support local *Guided Pathways* efforts. In addition, in collaboration with Chancellor's Office staff, Regional Coordinators will facilitate partnering within the geographic region and across the entire state system in order to ensure the deeper penetration of best practices and the widespread sharing of field expertise.

Join us in this important work that will shape the future of the California Community Colleges system and directly impact generations of students to come!

## **DUTIES AND RESPONSIBILITIES**

## Facilitate support and coordination for college/regional *Guided Pathways* capacity building and management:

- Identify, document, and track individual college and regional needs and trends related to guided pathways inquiry, design, and implementation
- Analyze college/regional data gathered from statewide tools, self-assessments, work plans and college visits
- Track and synthesize guided pathways (and other related initiatives, i.e. AB705) implementation progress at the college and regional level for internal and external CO reports and review
- Coordinate with external partners (e.g., CLP, LFM, the RP group, Academic Senate, and 3CSN) to maximize alignment, coherence, and implementation fidelity in guided pathways-related support materials
  and (or events)

- Design and coordinate the regional, college-specific and/or topical events relevant to guided pathways implementation
- Support the development of feedback loops between the Chancellor's Office and the field
- Coordinate with guided pathways evaluators as relevant and needed
- Support and facilitate development of relevant support materials and resources, including the review and release of online and face-to-face tools for use in the field

- Meet regularly with and support Guided Pathways leadership and other regional coordinators to achieve Vision for Success goals
- Convene and meet with regional leaders and groups to advance Guided Pathways
- Attend and participate in Chancellor's Office events relevant to Guided Pathways implementation
- Travel extensively within an assigned region within California
