RE: COVID-19 Guidance – BRN Requirements for Nursing Clinical Hours

The purpose of this memo is to provide an update to colleges impacted by the closure of partner clinical sites due to COVID-19 and to share our efforts to identify solutions or alternative options.

There are three issues the Chancellor's Office is currently working to address regarding Nursing Clinical Hours:

1) Flexibility and Emergency Conditions Exemptions to the 75 Percent Requirement

The Chancellor's Office has submitted a request to the Governor's Office for emergency conditions exemptions. Specifically, the request is for the Board of Registered Nursing (BRN) to provide emergency conditions exemptions to the 75 percent requirement of clinical hours in direct patient care, reducing to it to 50 percent for programs affected by an emergency or extraordinary condition.

In the coming days and weeks, we will continue to advocate for flexibility and work in partnership with the Administration, Senate and Assembly leadership for a solution that enables student completion of nursing clinical hours. Please be patient and stand ready to coordinate with key partners to expedite partnerships when we have an emergency exemption granted.

2) Alternative Options for 75 Percent Clinical Hours in Direct Patient Care

California regulations governing nursing education provide as follows:

The course of instruction shall be presented in semester or quarter units or the equivalent under the following formula:

(1) One (1) hour of instruction in theory each week throughout a semester or quarter equals one (1) unit.

(2) Three (3) hours of clinical practice each week throughout a semester or quarter equals one (1) unit. With the exception of an initial nursing course that teaches basic nursing skills in a skills lab, 75 percent of clinical hours in a course must be in direct patient care in an area specified in section 1426(d) in a board-approved clinical setting.

(16 Cal. Code Regs., § 1426)

In a call with the BRN this week, additional clarification was provided regarding the 25/75 percent requirements. Current regulations are silent about the use of simulation in the 25 percent. Colleges have the discretion to determine how the skills lab portion of the curriculum is met.

For the 75 percent clinical hours in direct patient care requirement, the regulation does not specify that direct patient care must be completed in a face-to-face or a hospital setting. For example, the requirement may be met in a community or public health setting, as well as utilizing telehealth and telephone triage with scripts.

Please also see the attached email sent by *Loretta Melby, RNC/MSN*, Acting Executive Director of the California Board of Registered Nursing, on March 17 to Deans and Directors of Nursing Programs.

We recommend that BRN programs discuss with Partner Clinical Sites the possibility of altering Clinical hours to include telehealth or telephone triage options, and include your **Nursing Education Consultants** (NECs) in these discussions to ensure any new format is compliant with regulations.

3) NCLEX Testing

We are aware of the suspension of NCLEX test delivery by all U.S. and Canada-based Pearson VUE-owned test centers beginning March 17 until April 16, due to COVID-19 pandemic. The Chancellor's Office is monitoring this situation closely.

Please note that National Council of State Boards of Nursing (NCSBN) Learning Extension is extending NCLEX-RN and NCLEX-PN prep course subscriptions by 45 days. The extension applies to active courses (as of March 17, 2020) purchased between January 17, 2020 and March 17, 2020. Users should see the additional days added to their subscriptions by early next week. The COVID-19 outbreak is a rapidly changing situation. Please keep this in mind when purchasing new course subscriptions.

We would also like you to be informed regarding the following:

Closing of College Campuses – On March 19, the Governor issued a statewide stay at home order. This means that you must reduce your campus operations to a bare minimum of essential functions. Only “Essential Personnel” may be allowed on campus. Colleges and their local boards determine who is designated as “Essential” based on college district Emergency Operations Plans. All non-essential personnel must be sent home and teleworking protocols initiated for them. Nevertheless, colleges should continue to provide remote instruction to their students. The Governor is directing that the system continue to provide instruction and to follow the guidance provided by the California Department of Public Health (CDPH) and directives of local health authorities.

We understand that many of you need additional guidance to consider as you make local decisions. The Chancellor's Office will be seeking additional clarification regarding community college programs that serve critical infrastructure sectors such as Healthcare and Public Health, Emergency Services, and Food and Agriculture sectors, and continuation of instruction where appropriate and necessary, given the feasibility of moving many of these programs completely online.

The Chancellor's Office is reviewing flexibility options to allow extending excused withdrawals, and therefore avoid students dropping out and having to unnecessarily retake courses. Given the importance of nursing programs in the COVID-19 pandemic, colleges are asked to do everything possible to convert to online alternative instruction, to not close programs, or find ways to postpone until it is feasible to resume these programs. Good afternoon

We have received several notifications and inquiries on what to plan for regarding clinical and theory hours as the CDC and CDPH continue to send out information on the coronavirus with suggested responses. Currently, our Board and DCA with legal counsel are monitoring the situation and are looking in to various options. To date we are still bound by our regulation (e.g. Theory and clinical must be taken concurrently and clinicals need to be scheduled with 75% in direct patient care).

I have asked all Nursing Education Consultants (NECs) to collect the numbers to speak to the current impact of disrupted clinical rotations. When you are reporting this information to your NECs please include:

Clinical disruption

Name of the facility that has closed

How long is this predicted to last

How many clinical groups are displaced from that locations

How many students are in each group

What nursing content area the clinical rotation was in

How many hours of clinical the students have completed for that rotation

How many hours of clinical are still needed to compete the rotation

How many hours (percentage %) has already been used in simulation

What date does your semester/quarter is scheduled to end

Is your program year round or traditional

Have you contacted other facilities for direct patient care clinical makeups (how many? What is their response?)

What is your programs policy on missed clinical days

I have also heard that students may have limited experiences in facilities due to the lack of availability of personal protective equipment (PPE). If your student is not able to meet the clinical/course objectives due to this please report that separately as we are tracking that as well. If they are able to continue and the objectives will be met there is no need to report this.

In regards to theory: All theory courses and exams can be taught/taken remotely. Please submit a formal letter to your NEC requesting this temporary change along with an end date. When requesting this change please speak to the platform you intend to use, student availability to the platform, and your ability to support this type of instruction. This will be treated as a minor curriculum revision and your NEC can approve this immediately so that we will not delay your implementation. If you are considering resequencing your courses within your program to help alleviate some of the strain on your clinical situation, your NEC can also process this as a minor curriculum revision as well.

Your NEC will work with your programs on an individual bases as we try to navigate this. I appreciate all of you for working together and sharing our ideas.
