# Digest Item 1.3: Student Senate Update (SSCCC President Tervalon and SSCCC Vice President of Legislative Affairs Wooden)

This digest item presented updates on the SSCCC current initiatives, legislative stances, system participation, and the status of the SSCCC Board of Directors.

#### **Discussion Summary:**

- CCLC discussed the University of California and California State University systems support of the California Community Colleges Baccalaureate Degree program.
- ASCCC complimented the SSCCC on their conflict resolution training.
- CSEA echoed CCLC comments on Baccalaureate Degree support and encouraged discussions with local assembly state senate.

# Digest Item 1.4: Social Determinants of Educational Success Ecosystem: A Deep Look at Zero Textbook Cost (Executive Vice Chancellor Alvarado and Vice Chancellor Ruan-O'Shaughnessy)

This digest item provided an update on the California Community Colleges' approach to the implementation of the Social Determinants for Educational Success framework through the lens of the Zero Textbook Cost (ZTC) program.

#### **Discussion Summary:**

- CCCI expressed their support and inquired about unconditional belonging.
- CSSO discussed equitable access and categorical programs.
- FACCC inquired about funding on instructional materials.
- ASCCC expressed support to increase student access to high quality and structural materials.
- CCCT inquired about successful programs from a student perspective.
- CEOCCC encouraged long-term solutions.
- CCCCIO expressed their support for building infrastructure.
- ASCCC detailed a partnership with CCLC and requested ongoing funding for Open Educational Resources (OER).
- CSEA inquired about a CO status report to the Legislature.

# Digest Item 1.5: Participatory Governance Handbook and Statewide Engagement (Executive Vice Chancellor Alvarado and Assistant Vice Chancellor Martinez)

This digest item responded to the request for information from the Board of Governors to report on all statewide participatory governance structures by the Chancellor's Office, including statewide advisory committees, workgroups, and task forces.

#### **Discussion Summary:**

- ASCCC inquired about the Assembly Bill 1111 Task force, the modern policing program, and the transfer distinguished panel.
- SSCCC praised the CO's efforts and emphasized student representation on task forces.
- CCCCIO requested a main point of contact for the Participatory Governance Handbook and offered suggestions for future handbook updates.
- FACCC inquired about the process of updating the handbook.
- ASCCC suggested streamlining the handbook updates.
- CSSO suggested a timeline adjustment and expressed interest in including the Participatory Governance Handbook in their meetings.
- SSCCC offered suggestions for future handbook updates.

# Digest Item 1.6: 2021-2022 Enrollment Update and Early Data from Fall 2022 Student Survey (Executive Vice Chancellor Hetts and Executive Vice Chancellor Alvarado)

This digest item provided an update and opportunity to discuss changes in student headcount from 2019-2020 to 2021-2022 and preliminary results from the statewide survey of potential, current, and former students who had previously applied to the California Community Colleges as a follow-up to discussion from the Council meeting on August 18, 2022

# **Discussion Summary:**

- SSCCC expressed concerns about the drop in student enrollment and acknowledged the importance of contacting the student population.
- CCCCIO inquired about the data regarding the loss of the Asian Pacific Islander student population.
- CSSO highlighted the distinction between retention data and non-enrollment data.
- ASCCC inquired about survey outreach.

- CCCT encouraged a review of the CCCApply application process.
- FACCC inquired about partnering with the CO and Council groups on legislation regarding college affordability, basic needs, and work-life balance for students.
- CCCI discussed daycare, flexible scheduling, and issues with applying and registering to the CCC system.
- CCLC highlighted the upcoming Board of Governors meeting at which four CEO representatives would address enrollment strategy, management, persistence, and student success initiatives.

# Digest Item 1.7: Baccalaureate Degree Program Implementation Update (Vice Chancellor Lowe)

This digest item provided an update on Baccalaureate Degree Program implementation, and presented the programs approved by the Board of Governors President.
