NOTIFICATION

This is a formal notification of the intent to award the California Community Colleges Mental Health Services Grant Program Funds to 16 community college districts in accordance with the 2019-20 State Budget appropriation. Enclosed is a list of the recipient colleges of the Mental Health grants. This information will also be available on the Chancellor's Office <u>Mental Health</u> <u>Services webpage</u>.

PROCESS

The California Community Colleges Mental Health Services Grant Program applications were reviewed and competitively scored based on meeting minimum required objectives and criteria including: project need, response to need, work plan, project management, budget, overall feasibility, and sustainability of the project. The selected proposals will be recommended to the Board of Governors (BOG). All funds are pending approval at the January 2020 BOG meeting.

APPEAL DEADLINE

Applicants have ten business days from the date of this notification to file an appeal. For the purposes of this grant award, the deadline to submit an appeal is Tuesday, November 19, 2019 at 5:00 pm. Please refer to the Request for Applications (RFA 19-036) Section M Grant Appeal Procedures (page 15) for information regarding filing an appeal. If an appeal is filed during this period, the grants selected will not be awarded until the appeal is resolved. The appeal must specify the grounds of appeal and must be based on the process and/or procedures used in the review and recommendation of application for awards.

NEXT STEPS

The Board of Governors will meet on January 13-14, 2020 to review these recommendations and take final action. Upon approval by the Board of Governors, the Chancellor's Office will contact selected districts to discuss next steps in the award process.
