Standing Order of Business

- Call to order. Dr. LeBaron Woodyard called the meeting to order at 1:00 pm.

- Dr. Woodyard announced that the California Community Colleges Chancellor's Office and the SB 206 consultant met with the senate staffers of the co-authors of SB 26, which is companion legislation to SB 206. Coordination with the California Community Colleges Chancellor's Office will continue. The California Community Colleges Chancellor's Office's legislative director met with California Community Colleges Chancellor's Office staff regarding progress on recommendations for SB 206. In addition, a research project is in progress regarding transfer data for California community college athletes.

One comment was received by Aaron Detty of San Diego City College. Mr. Detty, expressed his concern in the Qsand As and in the chat voice option. He was asking “Could there be a limit to prevent “overgifting” by a team to student athletes allowing the student-athlete to sell big ticket items”, which to him equated to equitability for lower income student athletes. Mr. Detty’s question was disussed, and SB 206 working group responded to his question.
