Program Fund Return from Year One (2018/19)

This memo is inform the Regional Consortia and the Chancellor's Office Fiscal Agent Rancho Santiago Community College District of the return of Program Year One (2018/19) funds for the unspent Strong Workforce Program (SWP) K-12 Pathway Coordinator/ TAP Set aside dollars.

Per Education Code 88833(d), Any funds not used for the purposes identified in subdivision (a), (b), or (c) shall be added to the amount appropriated in the annual Budget Act for the K-12 component of the Strong Workforce Program, and provided to each consortium to create, support, or expand career technical education programs at the K-12 level that are aligned with the workforce development efforts occurring through the Strong Workforce Program.

The table below shows a summary of the redistribution totals scheduled to be returned to the host regions by the Chancellor's Office Fiscal Agent.

To access the funds, Regional Consortia will need to first enter into the NOVA system projects indicating how they plan to expend the funds in addition to indicating how they will meet the intent of the legislation. There is a maximum 24 months to expend these dollars. Regional Consortia may begin using these reallocated funds beginning May 2, 2022 based on projects entered and approved by the monitor via the NOVA system.
