1. It is the intent of the Legislature that industry-driven regional collaboratives perform services as participants of regional networks. Recipients of IDRC's shall provide a stable and flexible response mechanism for the identification of training priorities. They also will focus on the best use of resources on intensive projects for competitive, new and emerging industry sector technologies.

- 2. In addition to standard individual IDRC applications, this IDRC RFA seeks multi-college proposals for meeting the following acute labor needs:
 - a) A bundled sequence of industry-recognized credentials enabling students and workers to enter into and compete for jobs in the broad occupational ladders of priority and emergent industry sectors.
 - b) An approach to embedding employer-advised 21st century skills into existing Career and Technical Education (CTE) curricula and programs, including work-based learning coursework, in order to answer the pervasive call by employers to improve these competencies amongst graduates. The proposal should have a mechanism for employers to evaluate and recognize badges that demonstrate 21st century skills competencies.
- 3. Funding shall not be limited per project, but funding shall be based on the merit and reasonable costs for the anticipated outcomes and performance of the project.
- 4. Terms of the 2016-17 IDRC grant will be for 18 months.
- 5. *Submission of an initial <u>Letter of Interest</u> will be required only for multi-college networks or any college interested in joining a multi-college network with the intent of addressing the following acute labor market needs:
 - Industry-Recognized Credentials
 - 21st Century Skills

If there is already a multi-college network interested in this IDRC, only one Letter of Interest submitted by lead applicant is required and should outline all the involved colleges.

Letters of Interest must be completed and submitted electronically by *Friday*, *February 5*, 2016.

All Letters of Interest will be made public in order for interested colleges to contact each other and join or broaden their network. A college will not be allowed to participate in more than one application in the Industry-Recognized Credentials area and in the 21st Century Skills area.

NOTE: A Letter of Interest will not be required for those applicants that intend to submit standard individual IDRC projects that meet the needs and fill gaps in services that respond to regional needs of business, industry, employee, and workforce needs.
