RE: Formal Notification of Intent to Award for Pilot Colleges to Participate in the Invention and Inclusive Innovation (i3) Initiative

This memorandum is a formal notification of the intent to award for **Pilot Colleges to Participate in the Invention and Inclusive Innovation (i3) Initiative**, for the Workforce and Economic Development Division of the California Community Colleges Chancellor's Office.

The California Community Colleges Chancellor's Office, Workforce and Economic Development Division acknowledges the quality of applications and the ability to meet the need of introducing invention, innovation and entrepreneurial mindset skills to students. Pending Board of Governors approval, as well as the availability of funds, grant commencement will April 1, 2022. A list of the project applications and the funding status can be found in the "Intent to Award" table on page 2.

The Letter of Intent applications were reviewed and competitively scored by a selection committee. Review outcomes were either:

1. Funded – The application achieved at least the minimum number of points and otherwise met requirements for participating in the initiative.
2. Not Eligible – The application did not meet the submission criteria.

Applicants have ten business days from the day this memorandum is distributed and posted online to enter an appeal. If an appeal is entered during this period, the grants affected will not be awarded until the appeal is resolved. The appeal must specify the grounds of appeal and must be based on the process and/or procedures used in the review and recommendation of application for awards.

The Chancellor's Office will contact the institution receiving funding to request any technical changes, including budgets that are needed to complete the execution of the grant agreement. A copy of the fully executed grant agreement will be emailed to the institution.
