



Board of Governors Student Leadership Award Nomination Form

The Board of Governors Student Leadership Award honors community college student leaders who demonstrate the highest level of commitment to student leadership and Vision 2030 (www.cccco.edu/About-Us/Vision-2030).

Recipients will be announced and honored at the Student Senate for California Community Colleges Spring General Assembly, which will be held on April 4, 2025 - April 6, 2025. Recipients will receive a \$1,250 check and a commemorative certificate.

Nominations may be submitted from a college administrators, classified staff, faculty or students.

For full consideration, a completed nomination packet must include the following:

1. A nomination form completed by the nominator (including three short essay responses describing the nominee's dedication to Vision 2030, leadership to their fellow students, and a commitment to their broader community);
2. A copy of the nominee's registration statement from demonstrating current academic year or proof of degree completion or transfer within the last two academic years; and
3. A letter from a second nominator outlining the impact of the nominee's leadership to their college, community, or community college system.
