**RE:** Notification of the Student Transfer Achievement Reform Act of 2021 Allocations

The California Community Colleges Chancellor's Office is pleased to announce the release of a one-time \$65 million appropriation to support the implementation of identified Assembly Bill 928 (AB 928) provisions. AB 928 has directed the community colleges to:

- 1. place transfer students on an Associate Degree for Transfer (ADT) pathway where one exists for their identified major program of study and notate this action on their student education plans; and
- 2. implement a new replacement single general education pathway that was developed by the Intersegmental Committee of the Academic Senates in lieu of the existing general education for transfer frameworks.

#### **Background**

The Student Transfer Achievement Reform Act of 2021: Associate Degree for Transfer Intersegmental Implementation Committee, <u>Assembly Bill 928</u> (Berman, 2021) amended Education Code by adding <u>Section 66749.8</u> that directs the California Community Colleges "on or before August 1, 2024, where ADTs for major pathways exist," to "place students on the ADT pathway if students declare a goal of transfer on their mandatory education plans." Also, AB 928 requires colleges to utilize a new single general education framework that ensures students will meet academic eligibility and sufficient academic preparation for transfer admission to both the California State University (CSU) and the University of California (UC) commencing by the fall term of 2025-26. Titled "CalGETC", this new framework will necessitate that community colleges update those academic requirements in their publications, advising protocols, and relevant programming.

These new elements are intended "to maximize the probability that students will transfer into a four-year postsecondary educational institution and earn a degree in their chosen field of study in a timely manner, and to minimize the accrual of excess units." These efforts align with the Vision 2030 outcomes to increase with equity the number of community college students who transfer to a UC or CSU and to non-profit private/independent four-year institutions.

<u>Assembly Bill 183</u> (Higher Education Trailer Bill 2021-2022) allocated funds to assist community college districts with the implementation of transfer reforms required pursuant to Section

66749.8 of the Education Code. Funds allocated may be used for, but are not limited to, the following purposes:

- Reprogramming information technology systems to accommodate a singular general education pathway.
- Staff time to revise course catalogs and college policies and procedures to accommodate default ADT placement for students declaring a goal of transfer with a degree.
- Updating curriculum management or degree audit platforms.

## **Funding Allocation and Disbursement Formula**

The allocation provides an equal portion (\$565,217.00) for 115 brick-and-mortar colleges with transfer programs. See Appendix A for the list of colleges receiving an allocation. Funds will be disbursed in the First Principal Apportionment period, February 2024, following comprehensive guidance for planning local implementation (see ess-23-41, <u>Guidance for Implementing the New ADT Placement Requirement</u>, September 25, 2023 and intersegmental CalGETC guidance memo, forthcoming). Allocations are certified at specific points throughout the year and paid according to the Chancellor's Office standard <u>Apportionment Payment Schedule</u>.

#### **Spending Guidelines**

Colleges must spend their funds to implement the provisions in California Education Code, section 66749.8 and the Higher Trailer Education Bill of 2021-22. This may include augmenting staff or making required technological additions, modifications, and/or updates. Funding may provide resources for collaboration and coordination to help enact those cited expectations:

- Student placement onto an ADT where ADTs for major pathways exist, if the student declares a goal of transfer;
- Determination of any cited ADT exception from the required ADT placement action;
- Corresponding notation of ADT placement or alternative selection actions on the student's mandatory education plan;
- Update and verify all Transfer Model Curriculum (TMC) template forms for the approved ADTs with the new single general education pattern, CalGETC;
- Integration of CalGETC into all transfer materials, communications, and publications; and
- Appropriate programming within the college's enterprise system to automate these requirements as feasible.

### **Required Reporting**

Colleges will also be required to provide information on the expenditures of the allocated AB 928 Student Transfer Achievement Reform Act of 2021 funds to the Chancellor's Office by June 1, 2025. The report will be administered through an online survey, must include how funds were used for each of the allowable purposes, and an explanation of the effectiveness of the implementation efforts provided by the funds.
