RE: Final FY22-23 Allocation of Local and Systemwide Technology and Data Security

Ongoing Funds

The 2022 Budget Act included Assembly Bill (AB) 178 which allocates ongoing funds for the California Community College (CCC) districts to support improved oversight of fraud mitigation, online learning quality, and cybersecurity efforts. Districts were provided an initial, one-time allocation of AB 178 funds for fiscal year (FY) 2022-23 in February 2023. This memo describes the final FY 2022-23 allocation of AB 178 funds to districts.

Background

The Chancellor's Office collected information from the fall 2022 annual cybersecurity self-assessment and January 2023 bi-annual remediation reports to support compliance with AB 178. These data reveal significant End-of-Life (EOL) software and systems in use throughout the CCCs. Such technical debt represents a risk to local and systemwide operations, including delivery of high-quality online learning. As such the Chancellor's Office **strongly encourages** districts to expeditiously reduce and eliminate high risk technical debt and/or remediate other known security issues.

Funding Methodology

The final distribution of FY 2022-23 AB 178 funding, designed with input from the Systemwide Architecture Committee and Chief Information Systems Officer Association leadership, should be

considered a second one-time allotment and augmentation of funds provided to districts in P1. This funding will be distributed in P2.

Funding to districts is based on a minimum base allocation for EOL workstations and EOL servers up to a maximum relevant to each district's level of need (described in memo *DII 22-300-06*, dated January 20, 2023) and district-reported information in the January 2023 Remediation Reports, as follows:

- **EOL Workstations:** \$1,500 per workstation up to a maximum:
 - o Minimum allocation of \$72,000 for all districts, and
 - o Up to:
 - \$450,000 for HIGH need districts (approx. 300 workstations)
 - \$375,000 for MODERATE need districts (approx. 250 workstations)
 - \$300,000 for LOWER need districts (approx. 200 workstations)
- **EOL Servers:** \$7,000 per EOL server up to a maximum:
 - o Minimum allocation of \$28,000 for all districts, and
 - O Up to:
 - \$225,000 for HIGH need districts (approx. 30 servers)
 - \$187,500 for MODERATE need districts (approx. 25 servers)
 - \$150,000 for LOWER need districts (approx. 20 servers)

Districts may have more EOL technical debt than is associated with this funding allocation. The Chancellor's Office estimated a *reasonable* timeline for planning, decommissioning and replacement of technical debt by January 14, 2024, to improve the system's security profile significantly and relatively quickly.

To address EOL, these funds should be used to cover hardware, software, and services costs to facilitate workstation and server replacement, including EOL Windows operating systems. For funds not used for EOL replacement, the Chancellor's Office recommends pursuing other systemwide information technology-related priorities listed below:

- Replacing any Windows Server 2012 R2 that will reach End-of-Life on October 10, 2023
- Implementing Microsoft A5 Security Suite
- Implementing Tenable Vulnerability Scanner
- Maturing Information Security Training programs
- Supporting readiness to implement the Course Exchange as a Teaching College
- Implementing SuperGlue

Districts that did not submit a January 2023 Remediation Report will receive the minimum allocation of \$100,000.00. Funds will be distributed to districts in June 2023. The Chancellor's Office expects districts to report on progress toward eliminating EOL during subsequent AB 178 data collection points.

Remaining FY22-23 funds from AB 178 will be used to reimburse the Microsoft A5 Security Suite implementation services for high need districts. Given the noted timeline for implementation, highneed districts should submit reimbursement documentation to DII_Invoices@cccco.edu by November 1, 2023.

Future AB 178 Funding

FY22-23 AB 178 funding allocations have been designed largely to address vulnerability. All data collected in FY22-23 will be reviewed to understand progress toward improvement of the systemwide

security profile. Based on district-reported progress toward IT and security goals, the Chancellor's Office will revise the AB 178 funding strategy to better support local budget planning. Any changes to the AB 178 allocation strategy will be provided in a future memo.

Future allocations may be affected for failure to submit required reports by the due date.
