RE: Formal Notification of Related and Supplemental Instruction - FY24-25 One-time

Reimbursement for LEAs from FY21-22 and FY22-23

This memorandum is a formal notification of the initial allocation of related and supplemental instruction (RSI) hours funded by the FY24-25 appropriations. Upon appropriation by the Legislature, the Chancellor of the California Community Colleges (Chancellor) is responsible for allocating funds for apprenticeship programs in good standing and approved pursuant to Chapter 4 of Division 3 of the Labor Code consistent with subdivision (e) of Education Code Section 8152 or 79149.3 to reimburse RSI maintained by a school district, a county office of education, or a community college (collectively referred to as LEAs).

In FY24-25, the Legislature appropriated a total of \$1,133,000 on a one-time basis to reimburse local educational agencies for eligible related and supplemental instruction hours from prior fiscal years not previously funded owing to funding shortfalls. The distribution of these funds will be based on the proportion of the remaining eligible instruction hours from FY21-22 and FY22-23.
