The California Community Colleges Chancellor's Office in partnership with the California Department of Education is pleased to announce the release of a Letter of Intent (LOI) for the English Language Learner Healthcare Pathways Grant Round Two. The purpose of the Letter of Intent is to invite identified California Adult Education Program Consortia from the Round One cycle to participate in Round Two of the English Language Learner Healthcare Pathways Initiative. The Chancellor's Office will make awards based on the application materials submitted.

# Background

Under the Governor's Care Economy Workforce Development Package, the Budget Act of 2022-2023 included a one-time appropriation of Proposition 98 funds to support the development of limited-term, healthcare-focused vocational pathways for English language learners (ELLs) across all levels of English proficiency through the Adult Education Program to address regional economic healthcare needs.

To adhere to the Legislature's intent and maximize program outcomes, the California Community Colleges Chancellor's Office, the California Department of Education, the Labor and Workforce Development Agency, and the California Health and Human Services Agency formed an interagency workgroup and jointly developed a data-driven approach to determine the California Adult Education Program (CAEP) Consortia that are eligible for this investment. This investment is an opportunity for members of a CAEP Consortia who were selected and granted funding in the Round One FY 23-24 cycle, including community college districts and local education agencies, to continue to lead in the development of building adult education healthcare-focused vocational pathways within their respective regions.
