# PUBLIC COMMENT REQUEST PROCESS

#### The above-noticed meeting of the Board of Governors shall take place as follows:

**Public Comment:** Members of the public wishing to comment on an agenda item or another topic within the Board of Governors jurisdiction will be given the opportunity to do so in writing prior to the meeting, via Zoom, or in person at the location listed above. For any questions, please contact the Board Liaison at <u>CCastro@CCCCO.edu</u>. All comments will be limited to two minutes and the following policies.

- Written: You may email your comment request in advance to the Chancellor's Office at BoardComments@CCCCO.edu. In the email subject line, specify the item number associated with your comment. Persons seeking to address the Board on a topic not on the agenda must do so during the designated item listed as public forum. At the top of your email, you may identify yourself or indicate that you choose to remain anonymous. All written public comments must be submitted by the end of business, Wednesday, May 15, 2024. Comments received by the deadline will be provided to the Board of Governors and made public.
- **Virtual:** Use the Zoom platform's Raise Hand feature to address the Board. Persons seeking to address the Board on a topic not on the agenda must do so during the designated item listed as public forum. Individuals will be given the opportunity to address the Board in the order received.
- In Person: A written request to address the Board must be submitted on the form supplied by the Board Liaison. Persons seeking to address the Board on a topic not on the agenda must do so during the designated item listed as public forum. Individuals will be given the opportunity to address the Board in the order received.
  - The Board of Governors reserves the right to limit the total amount of time allocated for public comment on particular issues and for each individual speaker. (Gov. Code 11125.7.)
  - For members of the public utilizing a translator or other translating technology, the Chancellor's Office shall provide twice the allotted time to ensure that non-English speakers receive the same opportunity to directly address the Board. (Gov. Code 11125.7.)
