

NOTICE OF PROPOSED RULEMAKING CALIFORNIA CODE OF REGULATIONS, TITLE 5, REGARDING ACADEMIC PROGRESS NOTICE AND PAUSE & ACADEMIC RENEWAL

45-Day Notice published September 2, 2025

NOTICE IS HEREBY GIVEN, pursuant to Chapter 2 of the California Community Colleges Board of Governors (Board) Procedures and Standing Orders, that the Board proposes to adopt the regulatory action described below after a public hearing, and consideration of all comments, objections, or recommendations received regarding the proposed regulatory action during the public comment period, which closes on October 17, 2025.

CHANGES OR MODIFICATIONS TO PROPOSED TITLE 5 AMENDMENTS

Following the public hearing and considering all timely and relevant comments received, the Board of Governors may adopt the proposed regulatory action substantially as described in this Notice or may modify the proposed regulatory action if the modifications are sufficiently related to the original text. With the exception of technical or grammatical changes, the full text of any modified proposed regulatory action will be subject to a second 15-day notice period prior to its adoption at a subsequent Board meeting.

INFORMATIVE DIGEST

This first reading of this proposed regulatory action recommends amendments to Title 5, California Code of Regulations, sections 55031–55034 and 55046, that would change existing naming conventions for academic probation and dismissal and revise and standardize academic renewal standards within the California community college system. These revisions aim to normalize academic challenges as part of the learning process and reclassify the usage of academic standing from a deficit factor to an opportunity for improvement, learning, and ultimately program success across the system. These revisions would also make non-substantive amendments by updating the references to "probation" and "dismissal" in other regulatory sections accordingly. Specifically, the other sections to be amended in this non-substantive manner are sections 51018, 55022, 55024, 55510, 55521, 55523, 55525, 56404, 58106, 58108, 58621, and 58732.

Systemwide Change in Naming Conventions for Academic Standing

Currently, Title 5, sections 55031-55034 use naming conventions to classify students under academic probation, academic progress, continued program, and disqualification which often carry punitive or stigmatizing connotations. Terms like "probation" and "disqualification" can evoke associations with criminal justice or failure, leading students to feel ashamed, discouraged, or even fearful of continuing their education. This negative impact on student perception may result in increased attrition, as some students choose to drop out rather than seek support or re-engage with their academic journey.

To foster a more supportive and student-centered environment, several colleges within the California community college system have already adopted more compassionate and growth-oriented terminology. These changes have been informed by direct student input. Students who served on related task forces expressed strong support for renaming these academic statuses to better reflect encouragement, opportunity for improvement, and holistic support rather than punishment.

Academic Renewal

Currently, Title 5, Section 55046 grants districts a certain margin of freedom to craft their academic renewal policies. Though unintended, this has created an

inequity between colleges where, for the same circumstances, one college might grant academic renewal while another may not. The proposed amendments to this regulation will benefit community college students by ensuring a more standard and equitable application of academic renewal. Colleges are will also benefit, as standardization may inhibit "college shopping" by students seeking a second chance to succeed at colleges with alternative standards. The proposed amendments are intended to create a common expectation for students across the system.

Stakeholder Engagement

The Chancellor's Office recognizes the desire for a systemwide adoption of new, consistent naming conventions for academic standing that align with best practices and student feedback and acknowledges that this may trigger multiple changes throughout the system. For that reason, these revisions have been subjected to an inclusive process of advice and consent through a series of task force meetings. Stakeholder engagement was broad and representative and incorporated feedback and recommendations from the Academic Senate for California Community Colleges (ASCCC), California Association of Community College Registrars and Admissions Officers (CACCRAO), California Community Colleges Student Financial Aid Administrators Association (CCCSFAAA), Chief Instructional Officers (CIOs), Chief Student Services Officers (CSSOs), Association of Chief Business Officials (ACBOs), the Student Senate for California Community Colleges (SSCCC).

In the spirit of intersegmental consultation, feedback was also sought from the California State University (CSU) Office of the Chancellor, and the University of California Office of the President (UCOP) regarding potential transfer interactions with the other segments of California higher education. Discussions with the UCOP and the CSU Office of the Chancellor indicated that the proposed regulation and nomenclature changes do not pose any significant risk to the transfer process and are in alignment with recent efforts in their systems for similar nomenclature modifications.
