









- "Verticals" meet weekly


Steering Committee

- Tri-chairs meet weekly






RFP Selection/Contracting and Implementation Timeline





Wave 2 & Beyond

- Wave 1 goes live on June 1, 2026
- Wave 2 goes live Oct/Nov 2026
- Additional waves come online about every 4 to 6 months
- Call for participation in Wave 2 and beyond will begin in January 2026
