# K12 Strong Workforce Program Goal

Provide support for K–12 local education agencies (LEAs) in creating, improving, and expanding career technical education (CTE) courses, course sequences, programs of study, and pathways for students transitioning from secondary education to postsecondary education to livingwage employment



# **CTE Career Pathways**

- A framework for connecting a series of educational <u>courses</u> with <u>work based</u> <u>learning</u> and <u>student support services</u> that prepares a student for entry level employment in an identified industry sector.
- Begins in high school with two (2) Career Technical Education courses in an identified Sector.
- >Integrates work based learning strategies throughout the pathway.
- ➢ Based on Labor Market Information (LMI) Advisory Committees.
- Aligns with postsecondary Career Technical Education Certificate and/or Associate Degree.



# Articulation

- Articulation Agreements Credit for Prior Learning
- ➢Knowledge and skills equivalent to an approved college course.
- ➢Grade earned as posted in college catalog

- Board Policy (BP) & Administrative Procedure (AP)
- ➢ Faculty to Faculty Agreement
- Review on a regular basis, especially when new faculty involved.
- Evaluate student success as part of the regular review process.

## K-12 Pathway Coordinators Early College Credit Support

- Facilitate connections between colleges & K-12 LEAs to establish dual enrollment and articulation agreements

- **Connect practitioners with best practices** Examples: MOUs, board policy, bargaining agreement language, course curriculum etc.

# What is "Dual Enrollment?"

Refers to college course-taking by students who are simultaneously enrolled in K-12 schools. In some cases, the college courses also confer credits that meet high school graduation requirements.

# High School Articulation & Credit by Exam

# **Articulated Course**

• College faculty and high school instructor in a discipline have determined a high school course is aligned to a specific community college course.

## **Articulation Agreement**

- Formal, published document
- Verifies that college and high school faculty accept a course from the high school as aligned to a course at the community college
- Includes criteria students must meet to be eligible for college credit for that course.



# Credit by Exam

• Students receive college credit for the high school course through the Credit by Exam for Articulated High School Course



A robust body of evidence demonstrates that participating in dual enrollment improves student success in high school and in college. National research demonstrates that, compared to similar peers, dual enrollees, on average, have higher rates of:



The positive effects of dual enrollment on college degree attainment may be even more pronounced for low-income students than for their more affluent peers. Dual enrollment has the potential to yield public savings by reducing the time it takes to earn a college degree and improving the efficiency and effectiveness of higher education.



# College Readiness: "Prepared"

• College Credit Courses Complete two semesters, three quarters, or three trimesters of college coursework with a grade of C- or better in academic/Career Technical Education (CTE) subjects where college credits are awarded

# Career Readiness: "Prepared"

- Complete a CTE Pathway with a grade of C- or better in the capstone course and meet one of the additional criteria below:
  - Smarter Balanced Summative Assessments: Receive a score of Level 3 or higher in one subject area (ELA or mathematics) and a score of Level 2 or higher in the other area
  - Complete one semester/two quarters/two-trimesters of College Credit Courses with a grade of C- or better in academic/CTE subjects where college credits are awarded for each course



# Articulation & DuE:

- Provide a smoother transition for students to explore interests, careers, and majors while also earning college credit.
- Provide money savings for families.
- Give students a vehicle to complete an AA degree and high school diploma at the same time.
- Lead to higher rates of completion of certificates and degrees.
- Collaboration between K12 Districts and Cerritos College allows for alignment of curriculum and scaffolded supports to ensure equitable outcomes for all students.
- Colleges are more likely to support high school programs and offer resources when relationships are strong.
