Figure reports enrollment projection changes as a percentage of enrollment in 2021–22.

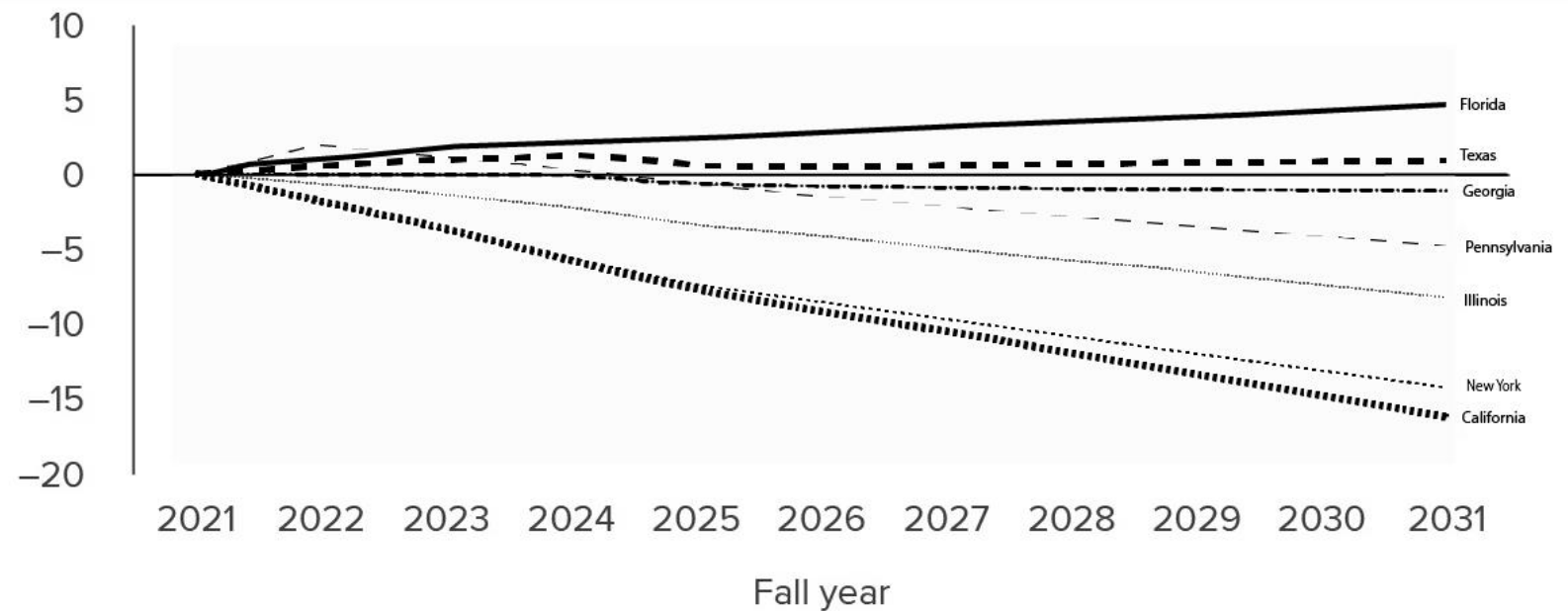

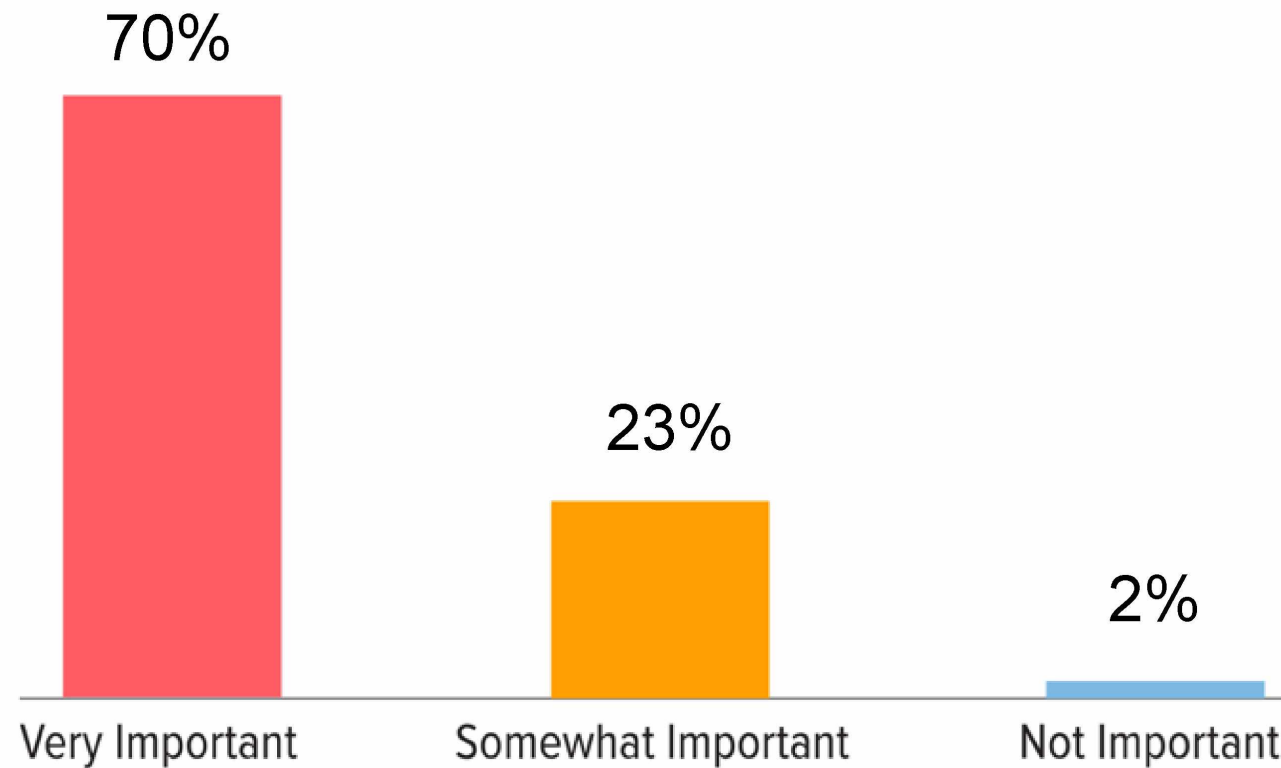


The Best Kept Secret?



A poll sponsored by the nonprofit Educational Credit Management Corporation reports that half (51%) of today's high schoolers are considering a college degree—a drop of more than ten percentage points from before the pandemic. 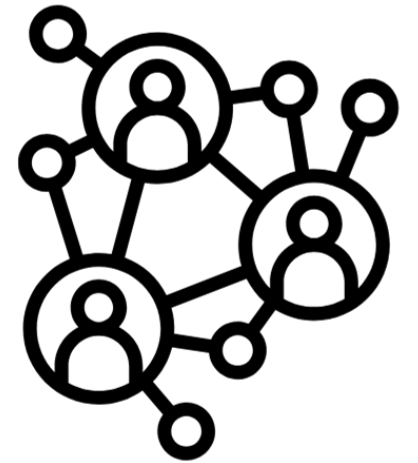

Where are we now?



Apprenticeship Pathways Demonstration Project (APDP)

Seeks to create and expand for-credit apprenticeship pathways, including providing credit for apprenticeship classroom instruction, on-the-job training and prior learning experiences.

- Create new credit courses or convert existing noncredit courses to credit
- Consider creating at least one certificate of achievement/associate degree
- Establish Credit for Prior Learning (CPL) policies to support apprentices
 - Work with MAP to incorporate existing apprenticeships into their platform

Importance of Optimizing Coding and Data Collection

- Ensuring accurate tracking of apprenticeship students, courses, and outcomes.
- Supporting sustainability of programs for RSI or FTES funding.
- Facilitating the transition of apprentices into and through credit-bearing programs.
- Ensuring apprentices do not incur unnecessary costs associated with education related to their apprenticeship program.
- Improving data integrity to support the development of certificates and degrees.
- Providing reliable data for CPL policies and standardization.

Creation of Apprenticeship Courses

- Do we need to create separate courses for apprentices?
 - No, colleges are not required to create separate courses for apprentices.
 - Traditionally, apprenticeship courses are created with CB 09 = A and restricting enrollment to registered apprentices.
 - Creating separate apprenticeship courses makes pulling information easier from systems like COCI, but apprentices can have traditional career education courses as part of their program of study
 - Courses with CB09 = A, B, or C count towards to the 9 units of career education courses in the Student-Centered Funding Formula (SCFF)

Assigning Courses to Disciplines

- Title 5 [§53200](#) outlines the authority of local academic senates including primacy over curriculum and assigning courses to disciplines
- Discipline assignment determines the minimum qualifications to teach a particular course
- Determined by local process, but Senate has regulatory authority
- Local process should rely on discipline faculty expertise with review and oversight by local Curriculum Committee, Senate, or both
- Curriculum Committee often charged with overseeing this process, but other models exist

What is a Discipline?

A “discipline” is defined as a grouping of courses that share common academic or vocational preparation, which are typically defined by a degree or degrees (MFA, MA, BA, MS, etc.), or specific professional preparation.

- **Not the same as local departments or subject areas**
- Defined in the Minimum Qualifications document maintained by the California Community Colleges Board of Governors

Example:

- Local Department or Subject Name: Child and Family Studies
 - Official Discipline: Early Childhood Education
-
- Discipline Definition in CA Education Code §87357
 - **Not the same as or related to TOP codes and names, or FSAs.**

Local Minimum Qualifications

- A district may establish additional qualifications which are more rigorous than the state-established MQs but beware of unintended consequences!
- However, local MQs **cannot** be less rigorous than the state-established MQs.

COCI Changes

- The Chancellor's Office has created a [PDF](#) to bypass the documentation requested by COCI because of a CTE TOP code
- Colleges can use this PDF now to create new certificates of achievement and associate degrees for DAS approved apprenticeship programs

Tracking Apprentices



Course Level Tracking

- Traditional apprenticeship tracking includes course level tracking where SAM A courses are examined
- When colleges have many apprentices in each program, having these courses are an easier way to track apprenticeship programs
- Traditional apprenticeship often had one set of courses for each employer
- Non-traditional programs with multiple employers may still benefit from using these types of courses

Course Considerations

- Advantages of SAM A courses
 - Courses are restricted to registered apprentices and can be coded to not charge fees in local ERP
 - Apprenticeship courses are easily tracked locally and at state level
 - Eligible to use apprenticeship minimum qualifications in Title 5, [§53413](#)
 - Building of local metrics can be done using only courses

Course Considerations (2)

- Disadvantages of SAM A Courses
 - Increased number of courses in the college catalog
 - Need to complete program review, SLO assessment and course review for all of these courses
 - Minimum qualifications may not align between apprenticeship courses and existing career education courses

Local Student Tracking

- Colleges should implement a local data element to track apprentices – especially if colleges are waiving fees for general education courses to complete AS degrees
- Possible considerations for local element
 - Registered Apprentice
 - Student in Apprenticeship Program Awaiting Approval
 - Program Specific – Different code for each apprenticeship program offered
 - Employer Specific – Different code for each employer tied to the approved apprenticeship program

State Level Coding of Students

SB 23 is used to code students that are part of an approved pre-apprenticeship or apprenticeship program

- **Code Value = 0:** NOT registered with the Department of Industrial Relations (DIR) or participating in a pre-apprenticeship program approved by the Division of Apprenticeship Standards through a Memorandum of Understanding
- **Code Value = 1:** Registered with the DIR an approved apprenticeship program
- **Code Value = 2:** Participating in a pre-apprenticeship program approved by the Division of Apprenticeship Standards through a Memorandum of Understanding

Challenges with SB23

- Many colleges begin enrolling apprentices prior to receiving approval from DAS
- Until students are a registered apprentice with DAS, SB23 should be 0, but the intent is to using SB23 = 1
- The Chancellor's Office often must look backwards at what students have done when they receive records from DAS

Options

- Decrease the time for DAS to approve new programs
 - AB345 (Jackson) has been introduced. The bill would grant conditional approval after 6 months if the apprenticeship program has been approved by the Department of Labor (federal).
- Add additional value to SB23 to track students enrolled in an apprenticeship program that is awaiting approval
 - Changes to MIS are usually only done once each year

Student Z Story and Unanswered Questions

- Student Z entered in Fall 2016 and finished in Spring 2021
- *Most terms*, the student enrolled in 2 or fewer courses
- The student may have been impacted by course availability during the pandemic
- The student is earning a regional living wage

All the things...

- We need accurate data to help tell student stories
 - Code the courses accurately
 - If it's Apprenticeship only, SAM Code = A
 - Identify when students enter an apprenticeship program (SB 23)
 - Some apprentices take other college courses. We want to know when they enter the college and when they start taking relevant courses
 - Colleges will be able to submit ITINs to the Chancellor's Office beginning Fall 2025
 - ...however, at this time, EDD will only provide wage data for students with an SSN
 - We are looking to expand MIS options for programs that have been submitted to DAS, but are awaiting approval
